Public offer
"Electronic gift certificates"

Limited Liability Company "M-BK" (TIN 9702055857, OGRN 1237700294974), represented by General Director A.I. Melnikova, acting on the basis of the Charter, publishes this public offer on the rules for the acquisition and use of electronic gift certificates when paying for services to access online products of the site (hereinafter: "content") purchased on the Internet at melannett.xyz.

Terms and Definitions

An electronic gift certificate is an electronic code that is not repeated in space and time (a set of symbols and signs in a human-readable form), which may be accompanied by graphic and other design, including the use of trademarks of the Seller or the Seller's partners, intended to account for the Seller's obligations to By the Buyer upon transfer to him/her of the goods(s) of the Seller or the Seller's partners in accordance with these Rules

Seller – M-BK LLC or its partners who accept Electronic Gift Certificates as a means of payment for the Seller's content or product(s) of the Seller's partners.

Acquirer - any individual or legal entity who has acceded to the terms of this offer agreement by purchasing the Electronic Gift Certificate(s) of the Seller or its partners, as well as actually possessing the Electronic Gift Certificate(s)) certificate(s) of the Seller or its partners, regardless of the basis for its/their acquisition (ultimate Acquirer)

Purchasing Electronic Gift Certificate(s) of the Seller or its partners - actions of the Acquirer aimed at receiving from the Seller and subsequent possession of the Electronic Gift Certificate(s) of the Seller or his partners, accompanied by payment(s) of the denomination (value) of the Electronic gift certificate(s) of the Seller or its partners, or receipt of the Electronic gift certificate(s) of the Seller or its partners for free.

Alienation of the Electronic gift certificate(s) of the Seller or its partners - actions of the Acquirer as the person actually possessing the Electronic gift certificate(s) of the Seller or its partners, aimed at loss of control (possession) by the Purchaser of the Electronic Gift Certificate(s) of the Seller or its partners, accompanied by receipt of payment of the face value

Sale of the Electronic gift certificate(s) of the Seller or its partners - actions of the Purchaser of the Electronic gift certificate(s) of the Seller or its partners aimed at fulfilling the technical instructions by the Purchaser (functionality of the website of the Seller or its partners) coming from the website of the Seller or its partners for the purpose of using the Electronic gift certificate(s) of the Seller or its partners by the Buyer to pay for the goods(s) of the Seller.

Basic provisions

1.1. Acceptance of the offer (that is, full and unconditional acceptance of all the terms of this offer) is the purchase by the Buyer of the Electronic gift certificate(s) of the Seller or its partners through his/their payment or free of charge/as a promotion of the Seller and/ or the Seller's partners.

1.2. From the moment of acceptance of this offer, the Seller or its partners have an obligation to accept from the Buyer the Electronic gift certificate(s) of the Seller or its partners, respectively, in payment for content and/or goods in accordance with the terms of this offer agreements of the Seller and offer agreements of its partners, published on the Internet. Rules

1.3. The purchase of an Electronic Gift Certificate(s) by the Seller or its partners confirms the mandatory familiarization with these Rules and their acceptance by the Purchaser/final Purchaser, as well as the execution of the corresponding Electronic Gift Certificate(s). -am) the Seller's partner is responsible for familiarizing the Buyer with the Rules of the Seller's partner published on the Internet.

1.4. Refusal to purchase content or goods paid for with Electronic Gift Certificate(s) of the Seller or its partners is governed by these Rules, the Public Offers of the Seller or its partners, respectively, posted on the pages of the Seller's website on the Internet, with with the following exception:

1.5. When returning a fee for the content of the Seller or the goods of its partners, paid using the Electronic gift certificate(s) of the Seller or its partners, the refund is made by issuing a new Electronic Gift Certificate(s) to the buyer) gift certificate(s) of the Seller or its partners, the denomination (value) of which corresponds to the value of the refundable fee for the content or fee for the product(s).

1.6. The purchaser of the Electronic gift certificate(s) of the Seller or its partners in the event of alienation of the Electronic gift certificate(s) of the Seller or its partners to a third party/persons is obliged to inform the person / persons to whom the Electronic Gift Certificate(s) of the Seller or its partners (the final Recipient)

are actually transferred/transferred, the provisions of these Rules and the Rules for the acquisition and use of Electronic Gift Certificates of its partners.

1.7. In the event of purchasing an Electronic Gift Certificate(s) from the Seller or its partners as a gift to another person, the Purchaser guarantees that he has warned him about the need for the Seller or his partner to process the recipient's personal data for the purposes of implementing the transaction/transactions.

1.8. The purchase of an Electronic Gift Certificate from the Seller or its partners is completed by sending the Buyer the electronic gift code via the website functionality of the Seller or its partners. certificate/activation code with instructions for its activation. This code is unique and can only be used once.

1.9. The validity period of the Seller's Electronic Gift Certificate(s) is indefinite, but not beyond the period of public provision of services for access to content (terms of marathons, life cycle of other site products). The validity period of the Electronic Gift Certificate(s) of the Seller's partner for the sale of goods is two years from the date of purchase from the Seller.

1.10. The purchaser has the right, without restrictions, to dispose of the Electronic Gift Certificate(s) of the Seller or its partners in favor of third parties. From the moment of purchasing the Electronic Gift Certificate(s) of the Seller or its partners, the specified individuals or legal entities acquire the status of the Acquirer of the Electronic Gift Certificate(s) of the Seller or its partners, with all rights and obligations under this offer agreement and the offer agreement of its partners.

1.11. The Seller undertakes, when the Buyer uses the Electronic Gift Certificate(s) of the Seller or its partners, to sell to the Buyer content or product(s), respectively, offered for sale on the website of the Seller or its partners, according to public offers sales of the Seller's services and remote sales of goods by the Seller's partners.

1.12. The purchaser does not have the right to present the Electronic Gift Certificate(s) of the Seller or its partners in payment for other Electronic Gift Certificates of the Seller or its partners, since the Electronic Gift Certificate(s)) The seller or his partners are not the product(s).

1.13. Electronic gift certificate(s) of the Seller or its partners cannot be returned, exchanged or replaced, including with other Electronic gift certificates of the Seller or its partners of a higher or lower denomination.

1.14. The purchaser may present the Electronic Gift Certificate(s) of the Seller or its partners within the nominal value to purchase content from the Seller or product(s) from the Seller's partner one time³.

1.15. If the cost of the content of the Seller or the product(s) of the Seller's partner selected by the Purchaser exceeds the denomination (value) of the Electronic gift certificate(s) of the Seller or its partners, or the balance of funds on it/them, the Purchaser of the Electronic gift certificate(s) of the Seller or its partners to pay for the purchase of the specified content or product(s) is obliged to pay the difference between the total cost of the selected content or product and the denomination (cost) of the Electronic gift certificate(s) of the Seller or its partners used to pay for content or
